

Agriturismo Pieve di Caminino Exceptional rules of conduct in Covid19 time (from November 2020)

IN THE INTEREST OF EVERYONE, IN ORDER TO ACCESS THE FARM DURING COVID-19 RISK TIME, IT IS COMPULSORY TO ACCEPT AND FOLLOW THE FOLLOWING INTERNAL RULES. BEFORE ARRIVAL YOU ARE REQUIRED TO:

- Carefully read all last updating for travelers in the [English page of the Italian Ministry of Health](#)



- **SELF-CERTIFY** of not having had contact with subjects who tested positive for COVID-19 and of not having transited in the last 14 days in areas at risk according to *World Health Organization* indications.

For access to the Caminino estate it is necessary to always have a body temperature below 37.5°C (as required by current legislation, body temperature can be detected, preventing access in case of temperature > 37.5 ° C), not have flu symptoms or any symptoms suggestive of COVID-19. It is also necessary to be equipped, before arrival, with an individual mask.

Our farm has been involved in the cleaning and disinfection of the rooms and materials with which you will come into contact to make your stay safer: during the covid-19 emergency period the availability of magazines and informative material is eliminated for mixed use. The information material will be available in digital format and sent by e-mail or WhatsApp.

How to clean and sanitize your hands

- Wash your hands often with water and soap (for 60 seconds) or use alcoholic solutions. Take specific care in washing before touching or handling objects / furniture which is in common with other people (to protect them) but also after having used them (to protect yourself).
- The Agriturismo provides dispensers containing sanitizing liquid placed close to the shared areas (swimming pool, car park). Please make sure you use these both when you enter and before leaving.

Use of mask

- During your stay, our farmhouse provides you with n. 1 masks per person. The use of the safe mask is a civic duty towards the people who are close to you and **it is necessary to always wear them once out of your apartment. Please be sure to always have a mask with you once out of your apartment and be ready to wear it if someone is walking close to you.**

Social Distancing

- Given the large availability of outdoor space of this farm, **in the interest of everyone it is necessary to always respect the minimum distance of at least 2.00 meters** in all phases of common life, with people not belonging to your family or domestic partnership. Pay particular attention especially where the use of the mask can be omitted, such as when sunbathing or diving in the pool (pool is available only from June to October).

Disposal of Protective devices

➤ Protective devices (masks and disposable gloves) must be disposed **only** using the undifferentiated waste bins that can be also used for tissues.

Young guests

➤ In order not to make all our efforts useless, it is mandatory that rules are respected by everyone, especially those concerning the social distancing and the use of protective devices: this applies also to children over the age of 6 and to minors which are under your responsibility.
If rules will not be respected by all, staff will be obliged to ask young guests to leave the communal areas.

Swimming pool (available just from June to October)

➤ As for entering the estate, also for using the swimming pool it is necessary to have a body temperature below 37.5°C (as required by current legislation, body temperature can be detected, preventing access in case of temperature > 37.5 ° C), not have flu symptoms or any symptoms suggestive of COVID-19.

➤ Before entering the pool, it is necessary to take a full shower with soap, and to do a hands and feet disinfection using the spray dispenser by the pool.

➤ Individual sunchairs will be available (two per apartment) which will be disinfected before your use. **You can use only the sunchairs with the name of your apartment on.**

➤ Access to the pool will not be continuous but only according a timetable, which may change depending on occupancy and risk. When and if possible, an exclusive or partially exclusive use of the swimming pool will be organized at times for each family/group or cohabitation, with the necessary sanitization intervals. When this is not possible, it is important to respect the social distance of at least 2 meters, maximum potential occupancy will be 14 people at a time.

➤ When using the swimming pool, all clothing and personal items must be stored in a personal bag.

➤ It strictly necessary to fully respect all swimming pool rules displayed in the signboard at the entrance of the pool.

Symptomatic cases

➤ In case of symptoms of respiratory illness, fever, coughing or sore throat remain in your accommodation and immediately call our cell phone **393.3356605** to inform us.

➤ In full compliance with the privacy policy we will call the competent authorities right away.

Checking in and checking out

➤ Arrival time is from 14,00 till 19,00. To simplify the welcome, we will check you in directly by your accommodation, where you will find free refreshment drinks (cold water and white wine).

➤ At check out (within 10,00am -11.00am when possible) we kindly ask to leave all the windows open, the keys on the table, and to dispose lines and towels in the supplied laundry bags.

IMPORTANT: access to the property, especially during covid19 time and post covid19 time, is strictly reserved only to booked guests. Visitors are NEVER admitted, no exceptions.
